- The Board will meet in closed session during the August meeting to conduct the Superintendent Evaluation Process, including a review of work accomplished and goals for the 2016-2017 school year.
- Nolte, Cornman & Johnson conducted an initial audit of Fiscal Year 2016.
- The District will begin to plan for renewal of the Instructional Support Levy (ISL).
- A joint District Staff PD with Central Decatur has been established for August 22, 2016 with Kim St. Martin. She is the Assistant Director of Michigan Integrated Behavior Learning Support and will work with staff to

- The Board approved Lisa Jones as the Lamoni School Board Secretary for the 2016-2017 school year. <u>Motion by</u> Shields, second by Bell. Motion carried unanimously.

- The Board moved to approve 2016-2017 pricing: No increase on School Book fees, Activity passes, Driver's
  Education, Band Rental and Facility Use Fees. School Lunch pricing increased as follows: Breakfast increased .05
  cents; Lunch increased .05 cents. Milk pricing stayed the same. <u>Motion</u> by <u>Dickey-Kotz</u>, <u>second</u> by <u>Shields</u>. Motion
  carried unanimously.
- The Board approved the Lamoni Chronicle as the official Newspaper Publication for the 2016-2017 year. <u>Motion by Shields, second by Bell</u>. Motion carried unanimously.
- The Board moved to approve American State Bank as the Lamoni School District official depository with a maximum of \$350,000 and ISJIT. *Motion* by Shields, second by Heltenberg. Motion carried unanimously.
- The Board moved to approve the 2016-2017 Hy-Vee Bread Bid and Anderson Erickson Milk Bid. <u>Motion</u> by Bell, <u>second by Shields</u>. Motion carried unanimously.
- The Board approved to approve Verle Norris as the School Attorney for local matters and *Ahlers and Cooney* for more complex educational issues. *Motion* by Shields, second by Bell. Motion carried unanimously.
- The Board tabled the review of the 2016-2017 Athletics Handbook until next meeting after appropriate review. *Motion* by Shields, second by Dickey-kotz. Motion carried unanimously.
- The Board moved to approve the \$95 per day rate for Substitute Teacher pay for the 2016-2017 school year and \$11.15/hour for Substitute Teacher Aides/Special Education Paraprofessionals. *Motion* by Bell, second by Dickey-Kotz. Motion carried unanimously.
- The Board moved to approve Americorp contract for the 2016-2017 school year. The program provides 1 FTE to
  work with and support at-risk Middle School students at a cost of \$1,700 to the District. <u>Motion by Bell, second by Dickey-Kotz</u>. Motion carried unanimously.
- The Board moved to replace the 2007 Dodge Caravan and purchase a 2016 Dodge Caravan from Pettijohn Auto, Bethany, Missouri. *Motion* by Shields, second by Dickey-Kotz. Motion carried unanimously.
- The Board moved to approve the Delta Metals bid to fix the High School Gym roof flashing <u>Motion</u> by <u>Dickey-Kotz</u>, <u>second by Shields</u>. Motion carried unanimously.
- The Board moved to approve the Greenhouse Renovation in the amount of \$24,085.48 by Stuppy. <u>Motion by Dickey-Kotz, second by Heltenberg</u>. Motion carried unanimously.
- The Board moved to approve KCL Engineering design proposal of the Middle School Wiring and High School Gym lighting. *Motion* by Heltenberg, second by Shields. Motion carried unanimously.
